All individuals who believe in the principles, nature, and purpose of Faith Christian Fellowship of Canada Inc., may make application to become a part of this Fellowship if they fulfill the following requirements:

- 1. Must be at least 21 years of age.
- 2. Must be called of God to minister (Ephesians 4:11)
- 3. Must be involved in the ministry.
- 4. Must have completed one of the following:
 - a. One year of college or formal Bible training.
 - b. One year in active full time ministry.
 - c. A combination of the above totaling one year.
- 5. Must agree with the FCF Canada Tenets of Faith.
- 6. Must return completed packet, processing & annual fee to above address.

Action will **not** be taken on your application until all fees and completed forms have been returned to the above address. All completed application packets must include the following:

- 1. Application form.
- 2. Recent passport size photograph and a digital pic sent to dannis@rogers.com.
- 3. Application fee of \$175.00. (Should an application not be accepted, this fee minus \$75 processing fee will be refunded. Ministers who are accepted in the last quarter of the year will not have a renewal fee the following year.)
- 4. Two recommendations from persons who have known your ministry for two years.
- 5. Minister's Agreement to be signed after reading the FCF Tenets of Faith.
- 6. Statement of Ministry.
- 7. A detailed, typed resume containing education, employment, and ministry history.

IMPORTANT NOTICE:

- 1. All applications are to be completed and returned to FCF Canada office in Moncton.
- 2. An FCF Representative will contact the applicant for a telephone interview. Following this interview, the application will receive a final review by the Executive Board. This process could take 60 days.
- 3. License recognizes and confers upon approved applicants all the rights and privileges of a licensed minister including the authority to conduct communion, baptisms, burials, and other forms of Christian worship and sacerdotal functions in accordance with the Tenets of Faith of FCF Canada with the exception of performing marriages...

LICENSE RENEWAL INFORMATION

- 1. All credentials expire the first day of January. Annual renewal fees are \$100.00. Renewal forms and fees are due at the Canadian Office by December 31st to avoid late fees.
- 2. Renewals postmarked after December 31st will not be accepted until the late fee of \$25.00 is paid.
- 3. Renewals are the responsibility of the applicant. If you do not receive a renewal by November 1st, contact the Canadian Office.
- 4. Ministers whose renewals are not received by FCF Canada before April 1st will be placed on the inactive list and required to return their credentials.

FCF CRITERIA TO DETERMINE APPROVAL OR RENEWAL OF CREDENTIALS.

A combination of the following points is expected:

- 1. Applicant's **financial commitment to FCF Canada**. FCF desires a solid covenant relationship with every minister. FCF expects credentialed ministers to be committed to the vision through prayer and financial support. Giving is evidence of commitment, loyalty, and dedication, first to God and then to each other.
- 2. Applicant's commitment to continuing education.
- 3. Applicant's attendance at FCF Canada Conference, Regional Meetings, and Regional Gatherings.
- 4. Applicant's effort to make contact with their FCF Canada Representatives.
- 5. Applicant's correspondence and progress updates to the Canadian Office.
